



2014-15 STUDENT ENROLLMENT AGREEMENT

The student and the parent or legal guardian of the student enrolled (hereafter “the undersigned”) agrees that this Contract between the Wharton Music Center/New Jersey Youth Symphony (hereafter “WMC/NJYS”), and the undersigned covers the concert season beginning September 1, 2014 and ending June 30, 2015. The NJYS Attendance Policy for Rehearsals and Performances is incorporated into this Agreement and is made a part of this Agreement (available online as well).

1. The undersigned understands that he or she may cancel this Contract in writing, without penalty, on or before September 1, 2014.
2. The undersigned agrees to pay WMC/NJYS the required non-refundable tuition fee.
3. Tuition is due and payable by August 1, 2014. If the student named above has a sibling in the same or a higher-level ensemble in NJYS, the tuition fee for this specific contract is reduced by 10%.
4. The undersigned agrees that if the tuition fee for the student named above is not paid in full, the student may be excluded from rehearsals and performances.
5. The undersigned understands and agrees that the expenses of WMC/NJYS shall not be diminished by the departure of a student during the concert season covered by this contract and that the obligation to pay the tuition for the full season is unconditional upon signing this contract. After September 1, 2014, no portion of such tuition paid or outstanding will be refunded or cancelled, regardless of whether the student’s departure is due to dismissal for cause, due to absence, or voluntary withdrawal of the student.
6. Payment Plans are offered by NJYS as a courtesy. Should the undersigned be enrolled in a Monthly Payment Plan, they understand and agree that the expenses of NJYS shall not be diminished by the departure of a student during the concert season covered by this contract and that the obligation to pay the tuition for the full season is unconditional upon signing this contract. After September 1, 2014, no portion of such tuition paid or outstanding will be refunded or cancelled, regardless of whether the student’s departure is due to dismissal for cause, due to absence, or voluntary withdrawal of the student.
7. The undersigned agrees that, if the student named above violates the rules and regulations of NJYS in full or in part, **including but not limited to the enclosed Attendance Policy for Rehearsals and Performances**, then sufficient cause for dismissal may exist and the student may be subject to expulsion from the ensemble.
8. By signing this agreement, you consent to obey all rules posted or printed on materials at the NJYS facility and at concert venues, rehearsals and/or other officially sanctioned WMC/NJYS venues being used for an WMC/NJYS event. This includes concert halls which by contract with NJYS expressly forbid any recordings or photographs on the venue premise.
9. By signing this agreement, you consent to WMC/NJYS using information, pictures, photographs, or video pertaining to the musical activities of the student named above in media releases, on the WMC/NJYS

website, and in other communications. All photographs, audio recordings, and video recordings of concerts of ensemble rehearsals, special events, and concerts are and will remain the sole property of WMC/NJYS.

10. By signing this agreement and adding your name to the carpool question online, you consent to WMC/NJYS distributing your telephone number to other parents in your child's ensemble for possible car-pooling.
11. The undersigned agrees to indemnify, release and hold harmless WMC/NJYS, its agents, representatives, and employees against any and all claims, demands, damages, and any and all other liabilities for injury to the student named above which are not the result of gross negligence, intentional neglect, or willful or wanton conduct by WMC/NJYS, its agents, representatives, or employees. The undersigned further agrees to hold harmless and indemnify WMC/NJYS against damages to WMC/NJYS property caused by the student named above. In addition, the undersigned agrees to indemnify and hold harmless WMC/NJYS against damages or injury caused to another person by the student named above on WMC/NJYS premises or at WMC/NJYS events.
